Our Research

We only support research that has the potential to cure Parkinson's.

Our focus is on disease-modifying drugs. Drugs that will slow, stop and reverse Parkinson's. We are particularly, but not exclusively, interested in repurposing drugs already in use to treat other conditions. This approach accelerates progress, reduces costs and fosters partnerships.

Partnerships are very important to us as collaboration is the best way to find a cure, so we work closely with researchers, clinicians, other Parkinson's organisations, and people living with the condition.

Our research is often the springboard for further funding. For example, in 2019 the Australian Government committed AU\$30 million to identify the underlying cause of Parkinson's, initially testing the effectiveness of four repurposed drugs from our International Linked Clinical Trials programme (iLCT).

Our team has identified over 40 drugs to put into trial. This is a critical and exciting time for our work. Only through successful fundraising can we make this research happen, and help to identify new treatments to slow, stop or reverse Parkinson's.

Leave a Lasting Legacy


We know that gifts in Wills are a very personal matter, and your family and friends will come first.

However, if you're also planning to support a cause or a charity you care about, please consider a gift to Cure Parkinson's. You can be certain that your money will be spent with a clear purpose.

If you would like to discuss a possible legacy gift before you write your Will, we would be very happy to talk, and if possible, meet you.

Cure Parkinson's does not receive statutory funding, so all the money we raise comes from donations. Gifts left in Wills are the largest single source of donations to the UK charity sector.

Legacy gifts enable us to plan for future funding of research led by some of the world's top Parkinson's experts. This is the work that we believe will deliver results that lead to millions of lives being transformed around the world.





Your Gift is in Safe Hands

Much of our research is shaped by the international Linked Clinical Trials programme (iLCT). The iLCT committee is made up of top neurologists and neuroscientists from around the world as well as people living with Parkinson's.

This programme is the brainchild of Cure Parkinson's Director of Research, Dr Richard Wyse and chaired by the Director of the Center for Neurodegenerative Science at the Van Andel Institute, Professor Patrick Brundin. The committee meet once a year to prioritise the most promising drugs to fast-track into clinical trials, with the hope of not only proving efficacy but also shortening the time it takes for a potential treatment to move from the laboratory to clinical trials and, ultimately, to the patient.

Before we commit any of our donor's money to research, applications for research grants are reviewed by the charity's independent Research Committee which also includes outstanding neuroscientists and neurologists, who make recommendations to our Board of Trustees about funding. This process has been recognised as best practice by the Association of Medical Research Charities.

We have also appointed one of our trustees as our "Legacy Champion" to ensure your gift is in safe hands and your legacy is focused on finding a cure.

Minnie's Legacy

A generous supporter named Minnie left Cure Parkinson's a large sum of money in her Will from the sale of her house. Minnie's incredible legacy was used to help fund one of our iLCT drug research projects.

How To Leave a Gift in Your Will to Cure Parkinson's

There are three ways you can leave a gift to Cure Parkinson's in your Will:

1. A Percentage or Share of Your Estate

For example, you could choose to leave 30% or $\frac{1}{4}$ of your estate to Cure Parkinson's, once all taxes and other payments have been made. This is known as a residuary gift

2. A Lump Sum

You might choose to leave a fixed amount of money to Cure Parkinson's, which is often referred to as a pecuniary gift. For example, this could be £200, £2,000 or £20,000. If you choose this type of gift, it's worth considering linking it to inflation. Without this it could mean the true value of this gift could become less than you intended

3. A Specific Item

For example, this could include jewellery, an antique or shares.

We are very grateful for any gift you leave to Cure Parkinson's.

If you are writing a new Will, you can simply add in your wishes. If you already have a Will there is no need to create one from scratch – you can make a simple change by adding an amendment called a 'codicil' to your existing Will.

A Gift to Charity Can Reduce Inheritance Tax

If your estate is worth over £325,000, Inheritance Tax (IHT) may need to be paid when you die. Often, leaving a gift in your Will to a charity can reduce the amount of tax owed.

Anything above your tax-free threshold is currently taxed at 40% - this means that beneficiaries of your estate will receive £6,000 for every £10,000 over the threshold your estate is worth. However, if you leave 10% or more of the total value of your estate to a charity, the tax liability on the rest of your estate will go down, from 40% to 36%. Making use of this could enable you to leave a legacy to a charity of your choice while helping anyone else you choose to leave an inheritance to, by lowering the amount of tax they would have to pay.

It is also worth noting:

- Gifts made to a UK charity in the seven years prior to your death are also covered by the same exemption from Inheritance Tax that applies to a gift to a family member or friend.

Giles' Story

The beneficiaries of an estate can amend a Will after someone dies provided it is done within two years.

Giles, a supporter of Cure Parkinson's, was one of three beneficiaries included in a relative's Will whose estate was liable for Inheritance Tax.

As Giles explains, "I suggested we tried to benefit from amending the Will. Either we pay 40% tax on the taxable element or give 10% to charity and pay 36% on the rest. This doesn't sound very good but £1,000 less 40% = £600 while £900 less 36% = £576. So every £100 going to Cure Parkinson's only cost us £24. This is a tax refund of 76%.

"We did have some challenges; primarily we all had to agree to amend the Will and we all wanted to donate to different charities, so we gave it all to Charities Aid Foundation (CAF) and sorted it all out afterwards. For us, this turned out to be straightforward but please look at gov.uk/alter-a-Will-after-a-death and please get legal advice. Oh, and don't wait too long - you only have two years and you need to agree and sign forms!"

Whatever decisions you make about your Will, we recommend you ask a solicitor or a member of the Institute of Professional Willwriters (IPW) to write or amend your Will. They will be able to provide the advice on the correct wording.

Please ensure that, whatever gift you choose to leave, your Will includes our full name "Cure Parkinson's", our registered charity number in England and Wales (1111816) or Scotland (SCO44368) and our address, "120 New Cavendish Street, London, W1W 6XX".



Once You've Written Your Will

Make sure your wishes are known - your Will is a legally binding document that sets out how your estate should be distributed in the event of your death. We would encourage you to discuss your Will with your family and loved ones first, particularly if you are considering supporting a charitable cause. Many people find they fully support the decision.

If you decide to leave Cure Parkinson's a gift in your Will and would like to let us know then please do get in touch so we can thank you for your generosity, however, you of course have the right to change your mind at any time. Making a Will or any changes to it can be a big decision and we want you to do it in your own time so, be assured, although it helps us to know your intentions, we will never put you under any pressure.
